**Administrative/Biographical History:**

Karl Eugene Fortress (1907-1993) was born in Antwerp, Belgium on October, 13 1907. He arrived in the United States in 1915 and became a naturalized American citizen in 1923. Fortress studied at the Art Institute of Chicago, the Art Students League in New York, and the Woodstock School of Painting with Yasuo Kuniyoshi. During the Depression, Fortress worked in the painting division of the Works Progress Administration (WPA) Federal Art Project. In 1937, the WPA sent Fortress and other artists to Alaska to document Alaskan communities and landscapes.<sup>1</sup>

Fortress taught at the Art Students League, Brooklyn Museum Art School, Louisiana State University, Fort Wright College, and Boston University School of Fine and Applied Arts. He was a member of the Artists Equity Association, the Society of American Graphic Artists, the American Association of University Professors, and the British Film Institute. Fortress was awarded the Guggenheim Fellowship in 1946, was named an Associate of the National Academy of Design in 1960 and elected to full Academician in 1971.<sup>2</sup>
